Knowing these facts and in consideration of the Big Sky Draft Horse Committee accepting my entry, I hereby for myself, my heirs, executors, administrators or anyone else who might claim on behalf, covenant not to sue, and waive, release and discharge the Big Sky Draft Horse Expo Committee, it's officers, their successors and assigns, and volunteers, including their agents, employees and assigns or anyone acting for or on behalf, from any and all claims of liability for death, personal injury or property damage of any kind or nature whatsoever arising out of, or in the course of my participation in these events. This release and waiver extends to all claims of every kind or nature whatsoever, foreseen or unforeseen, know or unknown.
